I am directed by order of the Governor to say that the Governor is pleased to sanction an allotment of **Rs. 2,17,00,800/- (Rupees Two crore Seventeen lakhs Eight hundred)** only being placed at the disposal of the Commissioner, Backward Classes Welfare, West Bengal, to meet the expenditure of the scheme of Post-Matric Scholarship to Scheduled Tribes Students during the current year, 2015-2016 as per existing norms.

Out of the above charges of **Rs. 2,17,00,800/- (Rupees Two crore Seventeen lakhs Eight hundred)** only an amount of **Rs. 1,67,64,000/- (Rupees One crore Sixty seven lakhs Sixty four thousand)** only will be debited to the head of account "2225-Welfare of Scheduled Castes, Scheduled Tribes & Other Backward Classes-80-General-800-Other Expenditure-SP-State Plan(Annual Plan & XI/XIIth Plan)-025-Additional Financial assistance to Post Metric Hostellers [tw] -V-34-Scholarships & Stipends" (Code No.: 65-TW-2225-80-800-SP-025-V-34) and an amount of **Rs.49,36,800/- (Rupees Forty lakhs Thirty six thousand Eight hundred)only** will be debited to the head of account "2225-Welfare of Scheduled Castes, Scheduled Tribes & Other Backward Classes-80-General-800-Other Expenditure-SP-State Plan(Annual Plan & XI/XIIth Plan)-028-Additional benefits for Post Metric Hostellers reading in classes IX and XII [TW] -V-34-Scholarships & Stipends" (Code No.: 65-TW-2225-80-800-SP-025-V-34) Voted in the budget for the current financial year, 2015-2016 under Department Code "TW" and Demand No.65.

Post Metric Scholarship shall be disbursed to the students observing all guidelines and orders issued by this Department from time to time.


