Sir,

I am directed by order of the Governor to say that the Governor is pleased to accord sanction to an allotment of Rs. 48,00,000/- (Rupees Forty eight lakhs) only being placed at the disposal of the Commissioner, Backward Classes Welfare Directorate, West Bengal, to utilize the fund in connection with the observance of Ambedkar Medha Puraskar -2015 programme to be held in the month of December, 2015, in Kolkata and sixteen other venues in the districts of West Bengal.

The Governor has also been pleased to declare the Commissioner, Backward Classes Welfare Directorate, as the Drawing and Disbursing Officer in respect of above sanctioned amount and he is authorized to sub-allot the amount to the District Officers as per requirement. The expenditure should be met, following strictly the existing norms of the Government in this regard.

The Commissioner is hereby allowed to draw the amount of Rs. 48,00,000/- (Rupees Forty eight lakhs) only in advance vide Finance Department's U.O. no. Group T/2015-2016/0661 dated. 30.11.2015. subject to the condition that the advance to be drawn in Abstract Contingency bill and is to be adjusted by submission of the detailed contingency bill to the concerned PAO/Treasury in terms of the provisions of T.R. 4.138 of W.B.T.R. 2005 within stipulated time.

The above charges of Rs.48,00,000/- (Rupees Forty eight lakhs) only will be debited to the head of account "2225-Welfare of Scheduled Castes, Scheduled Tribes & Other Backward Classes-02-Welfare of Scheduled Tribes-796 Tribal Areas Sub-Plan -SP-State Plan(Annual Plan & XIIth Plan)-068-Promotion of Tribal Literacy & Cultural Activities [TW] -50-Other Charges (Code No.: TW-65-2225-02-796-SP-068-V-50) "Voted" in the budget for the current financial year, 2015-2016 under Department Code " TW " and Demand No.65

The fund will be disbursed to the District observing all guidelines and orders issued by this Department from time to time.

This order issues in exercise of the powers delegated under Finance Department. U.O. no. Group T/2015-2016/0661 dated. 30.11.2015. and in concurrence with the Financial Advisor of this Department, vide his U.O.no. 80 /FA/TDD, dated. 30.11.2015.


