4. The Commissioner, Backward Classes Welfare, West Bengal, will sub-allot the fund sanctioned herein to the implementing agencies as per quota following usual norms.

5. Utilisation Certificate, in duplicate, of the current year's allotment sanctioned herein should be furnished by the implementing agencies of this department in due course. No arrear payment shall be made out of this allotment.
