Sir,

In cancellation of this Department's previous allotment order vide no. 857-TDD/12S-82/2015 dated 17.08.2015 and 897-TDD/12S-89/2014 dated 26.08.2015, out of an amount of Rs 6350.84 lakhs received so far, a fund of Rs 3817.06 lakhs (Thirty eight Crore Seventeen Lakh and six thousand) only is hereby sub-allotted to P.O. cum D.W.O.s /D.W.O. s of different districts / Commissioner, BCW &TD Directorate for the following activities approved by the Project Appraisal Committee (PAC) of Ministry of Tribal Affairs, (MOTA) Govt. of India:

The District wise allotment is enclosed in Annexure I. In this regard attentions of all concern are drawn to the Detail Guidelines of MoTA of Art 275 (1) and SCA to TSP communicated vide Memo No: F. NO: 17019/01/2014-PC&V of MOTA Dated: 07.03.14, which is available in Website of MOTA. A copy of this circular has also been forwarded to you over e-mail communicated vide Memo No: SBCW-1020/14, dated 31.12.14 of Principal Secretary BCW.

P.O. cum DWO, / DWOs of different districts will draw their allotted amount as stated in Annexure I and utilise/ release the same to the concerned executing agencies for execution.

Commissioner, BCW & TD Directorate, needs to sub-allot the fund meant for recurring cost of EMRS to Po-cum-DWOs/DWOs of respective districts having EMRS as per their claims.

On completion of the scheme, the utilization certificate in duplicate and photographs of the schemes should be submitted to the Managing Director, WBSC&STDFC who in turn will compile and cause to send the UCs to TD Department. A copy of the UC needs also to be sent by the respective P.O. cum D.W.Os/D.W.O.s directly to Principal Secretary, Tribal Development Department. PO-cum-DWO/DWOs should also ensure that the Technical Agency executing the scheme certifies that the work has been done in accordance to the specific plan and estimates. Further all concerned are advised to abide by Memo no 5458 F(y) dated 27/6/2012 and 5400 F(Y) dated 25/6/2012 in course of execution of the schemes. PO-cum-DWO/DWOs are also advised to ensure and give a certificate to the effect that a signboard indicating that 'the scheme is funded under Art 275 (1) of the TD Department' is put up.

The Managing Director, West Bengal Scheduled Castes and Scheduled Tribes Development and Finance Corporation will place the fund of Rs. 3817.06 lakhs (Thirty eight Crore Seventeen Lakh and six thousand) only at the disposal of the P.O. cum DWOs, / DWOs/ Commissioner, BCW and TD Directorate, as stated in the Annexure I through the concerned District Manager of the Corporation/ directly for implementation of the scheme.

Before execution of the scheme from this fund, it has to be ensured that the fund from any other sources has not been received for executing the sanctioned scheme/work concerned. If any other fund is found to have been received for execution of the scheme, the fund sanctioned herein should be surrendered forthwith or an alternative proposal be submitted remaining within the overall guidelines.
