Sir,

I am directed to state that the Governor is pleased to accord administrative approval for an expenditure of Rs. 72,94,20,000/- (Rupees seventy-two crore, ninety-four Lakh twenty thousand) only for Old-Age-Pension during the year 2015-2016 to the Scheduled Tribes of 60 years and above living within the ambit of below Poverty Line in the rural areas of this State @Rs. 1000/-per person per month.

The Governor is further pleased to sanction and place an allotment of a sum of Rs. 72,94,20,000/- (Rupees seventy-two crore, ninety-four Lakh twenty thousand) only as 2nd installment at the disposal of the Commissioner, Backward Classes Welfare, who is hereby authorized to sub-allot the fund to the PO-cum-DWOs of the concerned Districts as per their requirements.
3. The Utilization Certificate should be furnished as early as possible from the date of issue of this order.
4. The charge of Rs. 72,94,20,000/- (Rupees seventy-two crore, ninety-four Lakh twenty thousand) only will be debited to the Head of Account"2225-Welfare of Scheduled Caste, Scheduled Tribe and Other Backward Classes-02-Welfare of Scheduled Tribes-796-tribal Areas Sub plan-Sp-state Plan-073-Old Age Pension to Scheduled Tribes[TW]-V-31-Grant-in-Aid-GENERAL-02-Other Grants" under Demand No.65 and Departmental Code 'TW'(Code"65-Tw-2225-02-796-SP-073-V-31-02") from the Budget of current financial year 2015-2016.
5. This is to add that allotment of funds is no authority to incur expenditure without previous sanction of government where such sanction is necessary under the standing rules and order.
6. This order issues in concurrence of Financial Adviser of this Department vide his U.O. No.35-FA/TDD dated 03.08.2015 and Finance Department's(Budget) order No.460-FB dated 21.07.2015.
