Sir,

I am directed by order of the Governor to say that the Governor is pleased to sanction an allotment of **Rs. 6,08,87,400/- (Rupees Six Crore Eight lakh Eighty Seven thousand Four hundred )** only being placed at the disposal of the Commissioner, Backward Classes Welfare, West Bengal, to meet the expenditure for the scheme of "Hostel Charges to Scheduled Tribes Students" reading at the secondary level and residing in school attached hostels (Pre-Matric) @Rs. 750/- (Rupees seven hundred and fifty) only per month per student during the current financial year, 2015-2016.

2. The Commissioner, Backward Classes Welfare, West Bengal, is empowered to sanction expenditure on account of the scheme in GO No. 3240-TW dt. 28.03.1964 read with GO No. 533-TW dt. 28.12.1974.
3. The above charge on this account will be debited to the following heads in the budget of the current financial year 2015-16 under Demand No. 65 and Departmental Code [TW].
  - i) **Rs.5,72,25,000/- (Rupees Five Crore Seventy-Two lakh Twenty-Five thousand )** only will be debited to the head of A/c "2225-Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes & Minorities-02-Welfare of Scheduled Tribes-277-Education-NP-Non-Plan-013-Hostel Charges[TW]-V-34-Scholarships & Stipends" (Code No. TW-65-2225-02-277-NP-013-V-34).
  - ii) **Rs.36,62,400/- (Rupees Thirty-Six lakh Sixty-Two thousand Four hundred)** only will be debited to the head of A/C ""2225-Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes & Minorities-02-Welfare of Scheduled Tribes-796-Tribal Areas Sub-Plan-NP-Non-Plan-016-Education Hostel Charges-Stipends[TW]-V-34-Scholarships & Stipends" (Code No. TW-65-2225-02-796-NP-016-V-34).
4. The Commissioner, Backward Classes Welfare, West Bengal, will sub-allot the fund sanctioned herein to the implementing agencies as per quota.

5. Utilization Certificate, in duplicate, of the current year's allotment sanctioned herein should be furnished by the implementing agencies of this department in due course. No arrear payment shall be made out of this allotment.
