

(Code No.: TW-65-2225-02-277-SP-021-31-02-V) "Voted" in the budget for the current financial year, 2015-2016 under Department Code "TW" and Demand No.65

Sikshashree will be disbursed to the students observing all guidelines and orders issued by this Department from time to time.
