Four Lakh Sixty Eight Thousand) only will be debited to the Head of account "2225-Welfare of Scheduled Castes, Scheduled Tribes & Other Backward Classes-80-GENERAL-800-Other Expenditure-SP-State Plan-029-Additional financial benefit to meritorious ST students[TW]-V-34- Scholarships and Stipends" (Code No: 2225-80-800-SP-029-V-34) in the budget for the year 2015-16, under Demand No.65, Department Code:"TW".
5. This is to add that allotment of funds is no authority to incur expenditure without previous sanction of Government where such sanction is necessary under the standing rules and orders.
